Ms. Williams said on November 14, 2018, she was involved in a serious car accident where serious injuries were incurred. She said she had to use the Emergency SOS feature which helped her get assistance quickly.

Ms. Williams said she wanted to educate the public on the F.A.C.T.S. of calling 911. She said the "F" stands for fake calls are illegal and can result in jail time. She said in the State of Ohio, inducing panic can be charged as a felony and even though we love our pets, 911 is for human emergencies only. She said the "A" stands for assign people to help you, you call 911, you do CPR, This happened to her. She said the "C" stands for stay

calm, cool and collected and don't send your body into more shock. Ms. Williams said the "T" stands for be as thorough as possible with the 911 operator details about the location, vehicle, injuries and what happened are very important. She said the "S" stands for staying on the line until help has arrived. She said if\_called by mistake tell them it was a mistake.

## **DISCUSSION OF CALENDAR ITEM**

## Calendar item No. 2. -ShotSpotter, Inc. - Service Agreement

The City Manager, Ms. Shelley Dickstein, said this agreement will use technology to enhance officer effectiveness, aiding potential victims and collection of evidence.

Ms. Dickstein invited Major Eric Henderson, Dayton Police Department, to the podium to provide clarification of the service agreement.

Major Henderson said in 2016 there was an increase in crime which garnered the need to organize the Gun and Robbery Crimes Units into one component and work alongside the Homicide Unit to create the Violent Crimes Bureau

Major Henderson said the Current Gun Crime Reduction Strategies is a partnership with the Federal Bureau of Identification (FBI), the Bureau of Alcohol, Tobacco, Firearms, & Explosives (ATF), placed based investigation (analysis of crimes, locations, suspects, and victims), and directed focused patrols.

Major Henderson gave an overview of the fear of gun violence in neighborhoods with Fair River Oaks Council (FROC) earning 85 percent of residential concerns. He said from 2012 thru 2018 West Patrol received the most gunshot related calls for service. He said West Patrols received 9,621 calls versus East Patrols receiving 3,703 calls.

Major Henderson said the way gunshot calls are received is a citizen has to call or an officer has to hear the shots being fired, when a citizen calls in a "shots" incident limited information is received. He said citizens are reluctant to call the police when shots are heard because its unknown where shots came from, could be fireworks or a car backfiring

Major Henderson said when the Gunshot Detection Technology system is installed in geographic areas, carefully selected based upon gun crime data, the system will cover a three square mile area and will automatically receive more accurate data and an actual recording of the gunshots heard in the area. He said it will allow police to respond quicker to actual shootings, in order to render aid, locate evidence, and utilize additional forensic tools, and it will serve as a community engagement tool since citizens will see the police in the area sooner.

Major Henderson said the impact on the community and crime is that the technology is in use in 98 cities which include Columbus, Cincinnati, Toledo, Canton, and Youngstown. He said San Francisco, CA has seen a 35 percent reduction in gunfire, East Palo Alto has seen a 27 percent reduction in gunfire, and Cincinnati — Avondale neighborhood has seen a 50 percent reduction in shootings since system deployed in August 2017. Major Henderson said project goas are to prevent gun crimes from occurring, decrease in the fear of gun violence, officers dispatched within two minutes to 90 percent of alerts, increase in evidence recovered from the scene, and to have 100 percent of casings entered into ATF's National Integrated Ballistic Information Network (NIBIN).

Commissioner Mims asked how the different sounds determined are.

Major Henderson said the sensors include computer algorithms which are sent to ShotSpotter, Inc. to determine what type of sound it is.

# <u>Calendar Item No. 3. – Wood Environment & Infrastructure Solution, Inc. – Service Agreement</u>

The City Manager, Ms. Shelley Dickstein, said the agreement will continue the support of the comprehensive source water protection program that includes several hundred monitoring wells to investigate and track potential contamination

The Temporary Chairperson, Commissioner Joseph, asked if the service agreement will monitor the newer wells or the entire system.

Ms. Dickstein said it is comprehensive; therefore, it will service both.

# Calendar Item No. 4. - City of Troy, Ohio - Other

The City Manager, Ms. Shelley Dickstein, said the revenue is a result of innovative revenue enhancements that is related to the pebble lime reclamation.
